Closed: New Year's Day, Memorial Day, 4<sup>th</sup> of July week, Thanksgiving and the day after, and the week between Christmas and New Year's Day.

**CHARGES:** (30' minimum, 19'6" maximum beam)

Hauling & launching, round trip: \$5.00 per foot\*

Hauling & launching using

4 straps or spreader beam \$6.00 per foot\*
Pressure washing \$3.00 per foot\*
Blocking \$3.00 per foot\*

Extra cushioning or blocking to protect chine rails may incur additional costs.

Pressure washing does not include scraping off excessive growth or disposing of it afterwards. This will be billed at \$65.00 per hour.

## STORAGE:

### Do-lt-Yourself/Liveaboards:

Short term \$1.00 per foot per day, includes power

\$4.00 per foot per week \$12.00 per foot per month

More than 2 people living aboard a vessel will be charged an additional \$5.00 per person per day.

# With no one working or living aboard:

2 month minimum \$6.00 per foot per month

**Transient Dockage:** 

With power \$1.50 per foot per night

Electricity, per cord:

15 amp service \$2.00 per day 30 amp service \$3.00 per day 50 amp service \$4.00 per day

# **Additional Charges:**

A 6.75% sales tax on material will be added when applicable.

A 3% environmental surcharge will be added to all invoice totals.

A cleanup fee may be assessed if work area is not kept clean.

Excessive waste and environmental problems will incur extra charges.

## PLEASE UNDERSTAND:

Owners are not allowed to change boat blocking or stands. Only Bock Marine personnel may do so.

Sandblasting and spray-painting is not allowed without prior permission from yard manager.

Bottom sanding must be done with a vacuum sander so bottom paint does not contaminate the soil.

Your subcontractors must be approved by yard manager, must have liability insurance, and must report to the office daily before performing any work on your boat.

For boats in long-term storage, roller furling sails and drain plugs must be removed and other sails and loose items secured.

# **Insurance and Damage Prevention:**

All boats should have hull and liability coverage. Bock Marine is not responsible for loss or damage to vessel or articles due to fire, storm, theft, winds, ice, spray painting, vandalism, or acts of God; nor for liability to owners, guests, etc. whether working or visiting the yard premises.

In the event of a severe storm, the yard will attempt to provide preparation and damage prevention service, the cost of which will be prorated over all boats. However, the owner is still responsible for taking all emergency precautions possible. Bock Marine will not assume any responsibility for said protection or damages.

Bock Marine is not responsible for maintenance checks on stored vessels unless prior arrangements are made, including interior flooding, mildew damage, and freeze protection.

## **Environmental Directives**

- 1. Clean area daily, disposing of trash, garbage, and waste materials into dumpster.
- 2. Household garbage should be put directly into dumpster; barrels around the yard are for trash only.
- 3. Drums are provided for recycling oil and used solvents.
- 4. Do not leave open containers lying about that may be knocked over or run over with rain water.
- 5. Notify yard personnel of spillage of hazardous materials so that proper measures can be taken.
- 6. Minimize use of detergents in cleaning boats. Use biodegradable substitutes when possible.
- 7. Smoking is not allowed inside any building.
- 8. Please see yard manager for disposal instructions of oils, thinners, solvents, antifreeze, etc.
- 9. Bottom sanding must be done with a vacuum sander.
- 10. Ground cloths should be used to catch chips when scraping off bottom paint.

## **Yard Policies**

Welcome to our facility. We appreciate the opportunity to serve you and promise to do the best job possible. To help us, please read and adhere to the following policies.

- 1. An owner or their agent must complete a contract before any work will begin on your vessel. Bock Marine accepts all major credit cards.
- 2. Outside contractors must be approved by yard manager and must provide a certificate of insurance. Please note that we charge according to our short term rates for subcontractors hired by boat owners.
- 3. The courtesy car can be used in 2 hour increments during working hours. We require a copy of your driver's license and ask that you gas up the vehicle according to your usage prior to returning to the yard.
- 4. No campers or mobile homes allowed in the parking areas.
- 5. Dogs must be leashed at all times and are not allowed in lounge. Please clean up after your pet.
- 6. We do not loan our tools or equipment.
- 7. Bock Marine is not responsible for any overspray or damage to your vehicle while on our premises.
- 8. No scavenging. Nothing in this yard or dumpster should be collected, used, or removed without permission.
- 9. We will gladly handle your incoming and outgoing mail, but please do not touch our mailbox it is against the law.
- 10. Customers are expected to help us maintain a clean and safe environment. If we determine the clean up is necessary, a fee will be assessed to that owner
